

# 校級組織委員會人文社會科學學院教師代表舉薦辦法

## Regulations for the Recommendation of Faculty Members to University-Level Committees as Representatives of the College of Humanities and Social Sciences

( Implemented September 27, 2023. )

第一條 國立東華大學人文社會科學學院（以下簡稱本院）為遴選校級組織委員會教師代表，依據各校級組織委員會組成相關規定，制訂「校級組織委員會人文社會科學學院教師代表舉薦辦法」（以下簡稱本辦法）。

Article I The National Dong Hwa University College of Humanities and Social Sciences (hereinafter referred to as the College) has established the *Regulations for the Recommendation of Faculty Members to University-Level Committees as Representatives of the College of Humanities and Social Sciences* (hereinafter referred to as the Regulations) in accordance with the relevant establishment regulations regarding the establishment of university-level committees, in order to select faculty members to serve on the committees as representatives of the College.

第二條 本辦法所規範之應舉薦本院教師代表之校級組織委員會及代表產生方式如下：

校務會議	<ol style="list-style-type: none"><li>1. 由本院全體教師（含專案教師）半額連記方式選舉產生。</li><li>2. 原則上依得票數多寡排序，但各系所班均至少應有 1 人入選。</li><li>3. 遇同票數狀況，由監票人於開票現場以公開抽籤方式決定當選（候補）順序。</li></ol>
校教師評審委員會	<ol style="list-style-type: none"><li>1. 由本院全體教師（含專案教師）以半額連記方式選舉產生。</li><li>2. 原則上依得票數多寡排序，但任一系所班當選委員至多 1 名。</li><li>3. 遇同票數狀況，由監票人於開票現場以公開抽籤方式決定當選（候補）順序。</li></ol>
教師申訴評議委員會	<ol style="list-style-type: none"><li>1. 由本院全體教師（不含專案教師）以全額連記方式選舉產生。</li><li>2. 遇同票數狀況，由監票人於開票現場以公開抽籤方式決定當選（候補）順序。</li></ol>
校課程委員會	採各系所班輪流方式自院課程委員中產生。
校務發展委員會	<ol style="list-style-type: none"><li>1. 由本院全體教師（含專案教師）以全額連記方式選舉產生。</li><li>2. 原則上依得票數多寡排序，但任一系所班當選委員至多 1 名。</li><li>3. 遇同票數狀況，由監票人於開票現場以公開抽籤方式決定當選（候補）順序。</li></ol>
教務規章暨成績更正審議委員會、學生社團評議委員會、學生急難救助基金管理委員會、外國學生入學暨獎學金申請委員會、推廣教	授權由本院院長舉薦產生。

校務會議、校教師評審委員會代表未獲得票者不得當選，連選得連任至多二次。連選連任委員三年或累計當選委員五次者，自次年起二年不列入候選名單。

Article II University-level committees that require recommendation of College faculty members as representatives and their appointment guidelines:

The representatives are chosen from the College's faculty (including contracted faculty members) via limited vote method.</li> <li>2. In principle, representatives are chosen based on the number of votes they received. However, there shall be at least one representative from each department.</li> <li>3. In cases where multiple candidates receive the same number of votes, the election's designated observer shall publicly draw lots on site to determine the allocation of vacant seats.</li> </ol>
University Faculty Evaluation Committee	<ol style="list-style-type: none"> <li>1. The representatives are chosen from the College's faculty (including contracted faculty members) via limited vote method.</li> <li>2. In principle, representatives are chosen based on the number of votes they received. However, there shall be at the most one representative from each department.</li> <li>3. In cases where multiple candidates receive the same number of votes, the election's designated observer shall publicly draw lots on site to determine the allocation of vacant seats.</li> </ol>
Faculty Grievance Committee	<ol style="list-style-type: none"> <li>1. The representatives are chosen from the College's faculty (excluding contracted faculty members) via block vote method.</li> <li>2. In cases where multiple candidates receive the same number of votes, the election's designated observer shall publicly draw lots on site to determine the allocation of vacant seats.</li> </ol>
University Curriculum Committee	The representatives are rotated through the departments and chosen from the collegiate curriculum committee.
University Affairs Development Committee	1. The representatives are chosen from the College's faculty (including contracted faculty

	<p>members) via block vote method.</p> <ol style="list-style-type: none"> <li>2. In principle, representatives are chosen based on the number of votes they received. However, there shall be no more than one representative from each department.</li> <li>3. In cases where multiple candidates receive the same number of votes, the election's designated observer shall publicly draw lots on site to determine the allocation of vacant seats.</li> </ol>

For the University Affairs Council and the University Faculty Evaluation Committee, candidates who receive zero votes are not to be elected and members may not be reelected more than twice. Committee members who have served on the committee for three consecutive years or who have served for five terms are not eligible for said committee's election for two years from the following year.

第三條 若屬新成立之校級組織委員會（尚未列入第二條者），本院院長得根據該委員會組成相關規定，先行裁示首屆本院教師代表產生方式，待下次系所班主管會議召開後再行討論該委員會第二屆起本院教師代表產生方式並載入本辦法第二條。

若遇原已列入第二條之校級組織委員會更名情況，得由院辦公室直接訂正本辦法第二條所列委員會名稱，無須循前述本辦法修正程序處理。

Article III For newly established university-level committees (that are yet to be listed in Article II), the appointment guidelines of faculty representatives for the committees' first term may be stipulated by the College dean in accordance with the relevant regulations regarding the establishment of said committees. The committees' appointment guidelines for faculty representatives starting from the second term will be further discussed in the next College Department Chair Meeting, during which these Regulations shall be amended for the inclusion of the new guidelines in Article II.

In the cases where committees listed in Article II change their names, the collegiate office

may directly make amendments to the committees' name in Article II of these Regulations without carrying out the aforementioned amendment procedure.

第四條 本辦法經系所班主管會議通過，陳請校長核定後實施。

Article IV These Regulations shall be implemented following the approval of the College Department Chair Meeting and the authorization of the president.
